



Dealer Participation Program

ATD-American Co. has been awarded the GSA contract for OFM, Inc. products. Under this contract, ATD-American Co. is the primary contractor. We encourage Participating Dealers. As a Participating Dealer, the following orientation and terms must be understood and complied with:

- 1) OFM, Inc. FSC Group 71, Part I (Contractor: ATD-American Co.)
- 2) GSA contract #: GS-28F-0010M
- 3) Contract Term: Dec.14, 2006 through Dec. 13, 2011
- 4) OFM, Inc. products under contract:

- 5) Purchase order and payment address: Participating dealers may not accept purchase orders or payments under this contract. All purchase orders must list ATD as the contractor as follows:

- 6) Quotes: All quotes for products or related services should be quoted by ATD to the end user. This will ensure that the quote to your customer includes correct pricing, terms, etc. ATD will copy the participating dealer on all quotes. Requests for quotes may come from the participating dealers to ATD. However, ATD reserves the right to contact the end user directly to confirm or clarify information. For details on inside delivery and installation, please see #8 on page 2.
- 7) Pricing: Pricing for products on contract is shown in the current ATD / OFM GSA catalog/price list. Please confirm pricing with ATD-AMERICAN prior to quoting customers, as price modifications occur annually. Please check the contract terms and conditions. These terms and conditions as well as pricing are non-negotiable.

- 8) Inside Delivery & Installation: All quotes for inside delivery and installation must be made directly to the end user by ATD. Participating dealers may quote installation to ATD; however, the dealer may be asked to submit proof of insurance.
- 9) Communication: To ensure accuracy, all end user questions regarding lead-time, delivery, logistics, customer support, and finance must be handled directly through ATD.
- 10) Design Fees: N/A.
- 11) Commissions: A commission will be paid 30 days after receipt of all invoice payments to the participating dealer. Credit card order commissions will be paid 30 days after shipping. Furthermore, no commission payments will be issued until the order is free of any and all customer service issues. Dealers should invoice OFM, Inc. for commission. All commissions will be paid directly to the dealer by OFM, Inc. Contact OFM directly for commission details and status.
- 12) Participating dealer installation charges: ATD will pay dealer installation invoices 30 days after receipt of customer payment and sign off from the end user stating the project has been completed to their satisfaction. Incomplete or unacceptable installations will delay payment and may result in invoice deductions if additional services are required for ATD to resolve customer installation issues.
- 13) Participating Dealers found to be in violation of any GSA contract terms of conditions will be subject to cancellation of this agreement.
- 14) To ensure dealer credit on your order, please complete and submit the GSA contract Project Registration Form. Contact your OFM representative to obtain the form and instructions.
